PRE-ACTION PROTOCOL LETTER OF RESPONSE

I write in response to your pre-action protocol letter before claim dated 11 December 2009.

The Claimant

The details of the matter being challenged

The Claimant challenges the Defendant's decision to remove postgraduate medical deaneries ("Deaneries") from the scope of the Conduct of Employment Agencies and Employment Business Regulations 2003 ("the 2003 Regulations").

Response to the proposed claim

The Department for Business, Innovation and Skills ("the Department") has, of course, already concluded a public consultation on a proposal to exempt Deaneries from the 2003 Regulations. The Department of Health is also in ongoing discussions with the BMA about how best to address the issues in relation to the conduct of Deaneries, and believes that all relevant matters, including the potential exclusion of Deaneries from the scope of the 2003







Regulations and the implications of that proposed course of action, have been considered in the course of these discussions. However the Secretary of State for Business, Innovation and Skills wishes to ensure that all interested parties have an opportunity to comment on these matters and that these comments are taken into account before he reaches the correct decision in the public interest. Therefore, the Department will be re-consulting on whether to exclude Deaneries from the 2003 Regulations before deciding which action to take. In particular, interested parties will have an opportunity to respond to the Department's concern that the continued inclusion of Deaneries would cause significant difficulties as regards training and recruitment arrangements for junior doctors. The Department does not have a firm date for publishing the re-consultation, but will ensure that the consultation document is sent to Remedy UK.
